Cleansing Statement & Application for Listing of Shares

On 7 April 2011 Atlas South Sea Pearl Limited (“Atlas”) (ASX: ATP) announced that it had raised \$768,000 through the issue of 6.4 million new ordinary shares in the company.


The final reconciliation showed that an additional 100,000 shares were applied for, by one of the same sophisticated investors, and \$12,000 had been paid. No shareholder approval is required for this additional placement as the amount raised represents less than 15% of the Company’s equity and the sophisticated investors are not related parties.

In making this placement, Atlas relies on Section 708A(5) of the Corporations Act 2001 (Cth) (“Act”) and gives notice as follows:

- a) the Company will issue the placement shares without disclosure to investors under Part 6D.2 of the Act;
- b) the Company is providing notice under Section 708A(5)(e) of the Act;
- c) as at the date of this notice, the Company has complied with the provisions of Chapter 2M of the Act as they apply to the Company;
- d) as at the date of this notice, the Company has complied with section 674 of the Act; and
- e) as at the date of this notice, there is no information:
 - i. that has been excluded from a continuous disclosure notice in accordance with the ASX Listing Rules; and
 - ii. that investors and their professional advisors would reasonably require for the purpose of making an informed assessment of:
 - A. the assets and liabilities, financial position and performances, profits and losses of the Company, or
 - B. the rights and liabilities attaching to the New Shares.


